2021 - SECOND QUARTER REPORT

ALL LOCAL UNIONS SYSTEM COUNCIL NO. 2

Dear Brothers and Sisters:

On May 26, 2021, the CN and KCS Railroads announced that they jointly filed with the Surface Transportation Board (STB) a renewed motion for approval of its voting trust that outlines the case for approval of the voting trust to advance the CN-KCS merger, that they claim will enhance competition, spur economic growth and realize the benefits of a fully end-to-end transportation network across continent. As part of the application, CN is committing to divesting KCS' 70-mile line between New Orleans and Baton Rouge, which is less than 0.7 percent of the approximately 27,000 route-miles the two companies operate. This commitment eliminates the sole area of overlap between the CN and KCS networks, making the combination an end-to-end transaction.

The Railroad Retirement Board (RRB) provides two kinds of benefits for qualified railroaders: unemployment benefits for those who become unemployed and are ready and able to work; and sickness benefits for those who are unable to work because of sickness or injury. Sickness benefits are also payable to female rail workers for periods of time when they are unable to work because of health conditions related to pregnancy, miscarriage, or childbirth. A new benefit year begins each July 1st. To qualify for normal railroad unemployment or sickness benefits in July 2021, an employee must have had railroad earnings of at least \$4,137.50 in calendar year 2020, counting no more than \$1,655 for any one month. Those who were first employed in the rail industry in 2020 must also have at least five months of creditable railroad service in 2020. As a result of recent action taken by the delegates to the 2021 System Council No. 2 Convention, three amendments to the System Council bylaws were submitted and unanimously approved as follows:

- 1. Article III, Section 1 extended the Convention "Notice" requirement from sixty (60) days to one-hundred twenty (120) days prior to convening the Convention.
- 2. Article IV, Section 1 included the Vice General Chairman as a member of the System Council No. 2 Executive Board, and reduced the members elected from the floor to the Executive Board from nine (9) to eight (8).
- 3. Article IX, Section 1 adjusted the System Council No. 2 per capita amount to (\$45.10) per month.
- One Resolution was also submitted and approved by the delegates recognizing retired System Council 2 Secretary Treasurer Randy Shell as

"Secretary Treasurer Emeritus".
