ALL LOCAL UNIONS SYSTEM COUNCIL NO. 2

Dear Brothers and Sisters:

An Executive Board position for System Council No. 2 was vacated due to Brother Dennis Bell's recent retirement. Therefore, pursuant to the System Council No. 2 bylaws, I appointed Brother Steven Fleming of Roseville, CA. Local 1682 to fill the Executive Board position vacated by Brother Bell for the remainder of the term. The appointment was then unanimously approved by the System Council Executive Board. We extend our gratitude to Brother Bell for his years of assistance and wish him the very best for a long and healthy retirement.

In 2020, the Union Pacific Railroad advised that they were discontinuing the Purchase of Services Agreement (PSA) between Chicago METRA and UPRR. As a result, numerous employees from each craft would be transferred from UPRR to METRA, including approximately sixty-five (65) IBEW represented employees currently employed by Union Pacific (Commuter Services). In November 2023, the IBEW finalized an implementing Agreement outlining the provisions and protection for the transfer of the IBEW employees. On June 3, 2024, the transfer was finalized and approximately 60 IBEW represented employees were transferred from UPRR to METRA (IBEW Local 214 to IBEW Local 134).
